

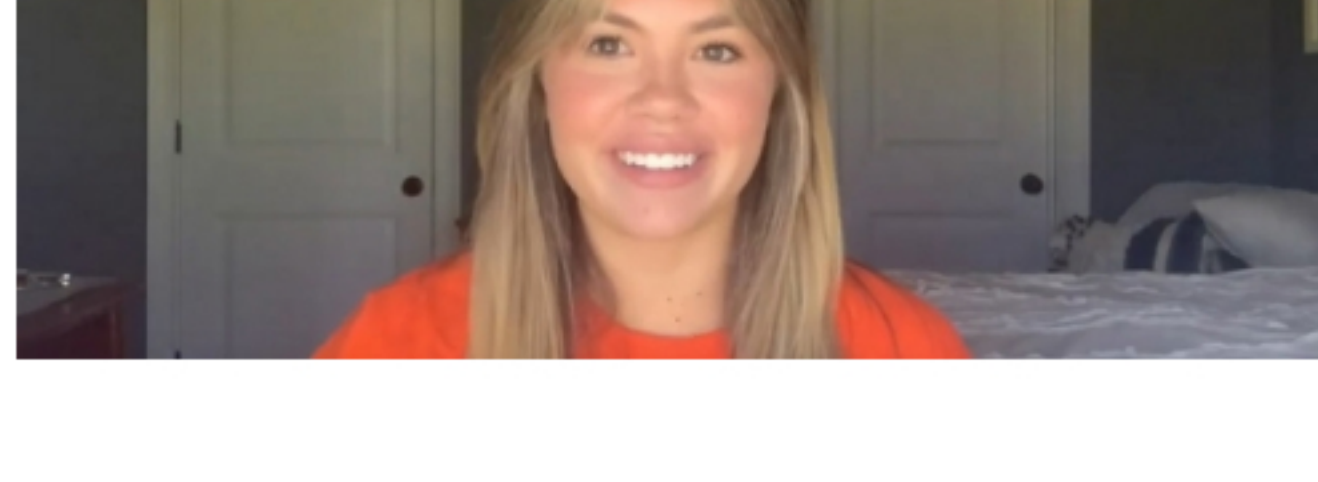


Greetings, Tigers!
