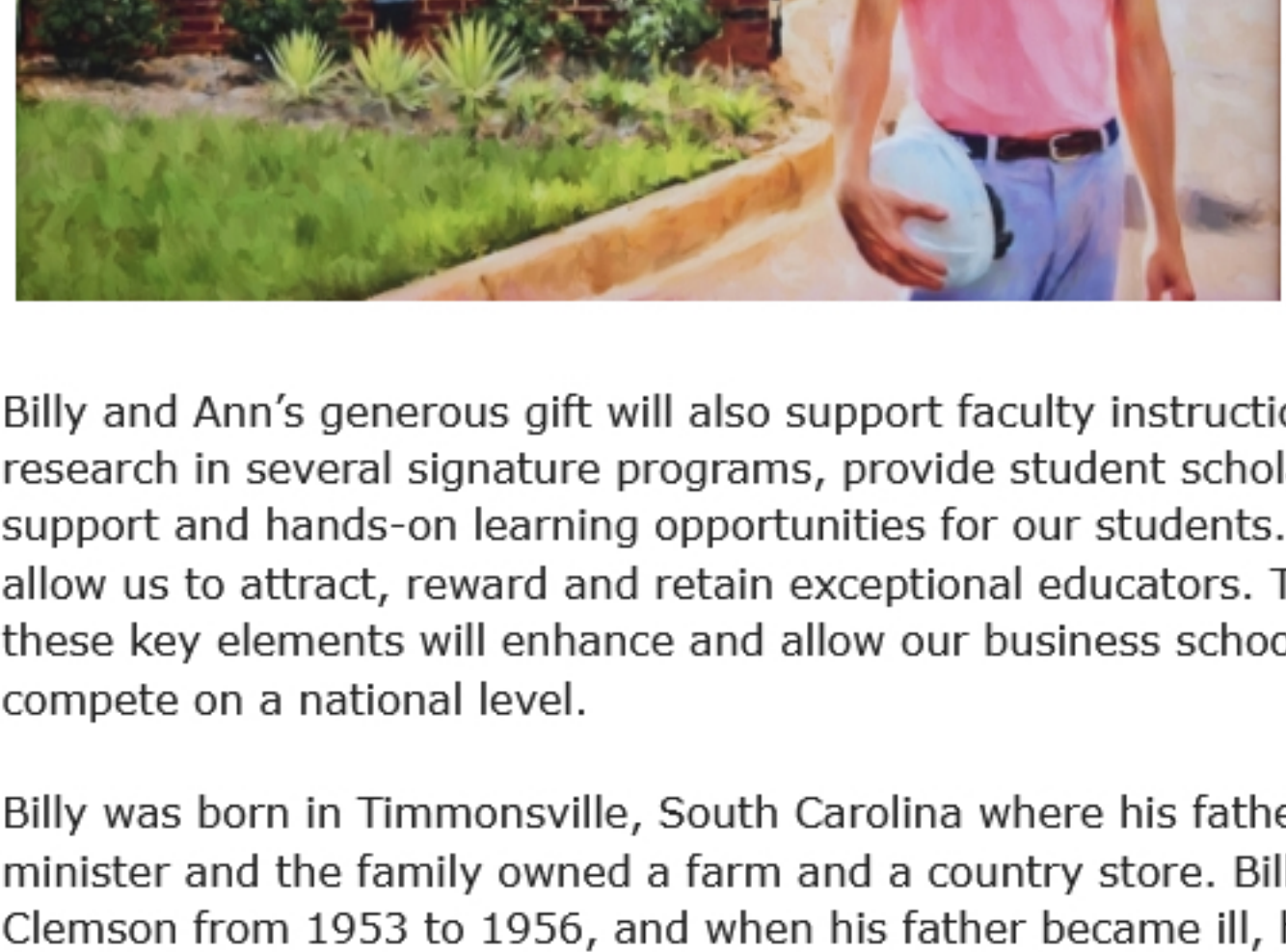

This is the **largest gift** in the history of Clemson University, one of the largest gifts ever given to a college or university in South Carolina and the **largest** gift from a Clemson alumnus. Billy and Ann Powers are two of the kindest and most outstanding individuals I have ever known, and it was a tremendous honor to play a small role in their magnificent gift. 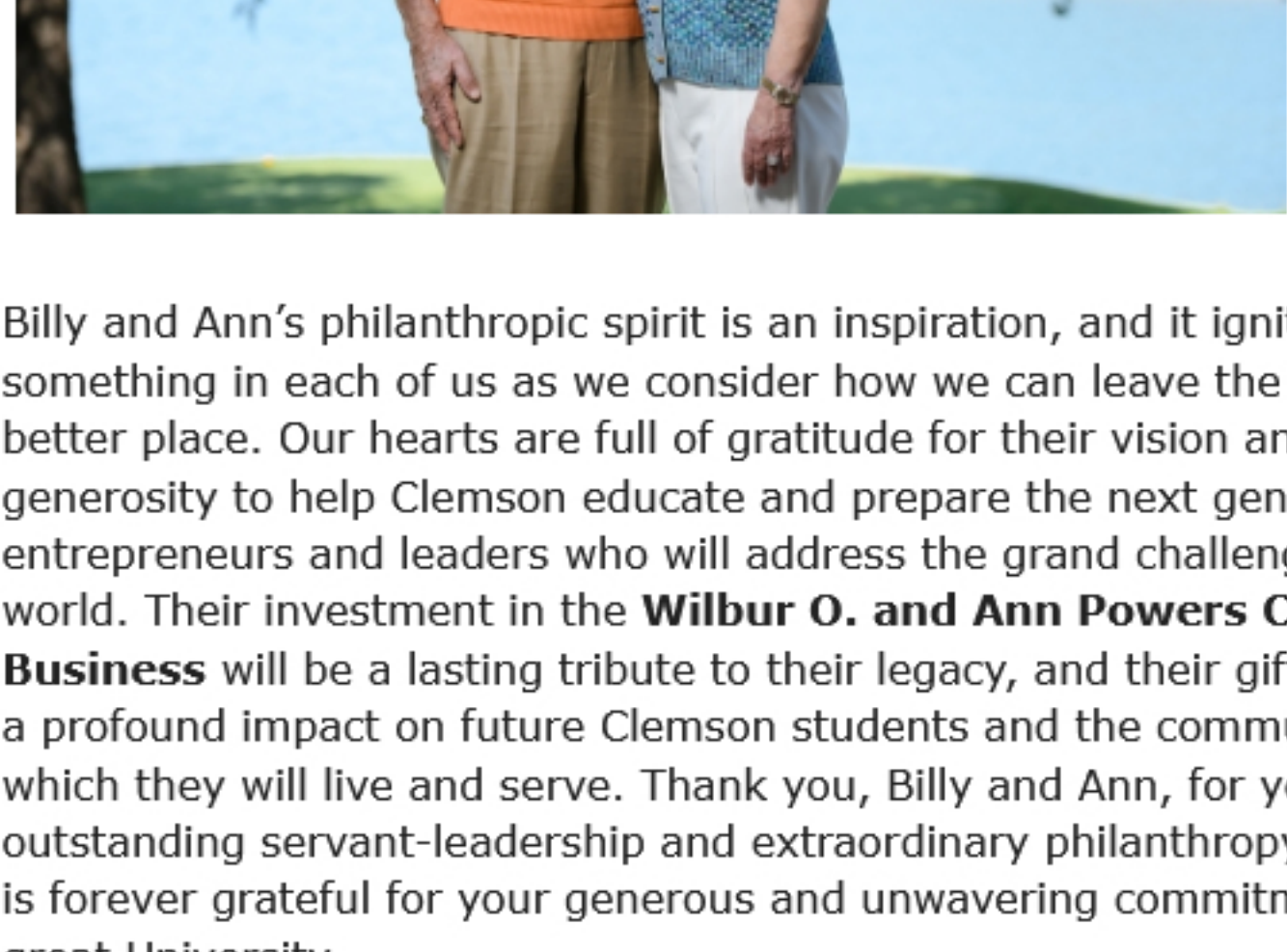
To honor Billy and Ann's historic investment, the College of Business will be named the **Wilbur O. and Ann Powers College of Business**. Their gift will serve as a catalyst to help Dean Wendy York and her team create one of the most dynamic and top business education programs in the country, shaping and positively impacting Clemson students to be outstanding leaders. The new state-of-the-art business building will allow our students to receive a world-class education in a captivating 176,000 square foot facility, located in the historic district of campus, directly across from Sikes Hall and Bowman Field.

The gorgeous complex, which opened this fall to our students, will be named the **Wilbur O. and Ann Powers College of Business**, as a physical marker and in recognition of Billy and Ann's extraordinary generosity. The South Tower will be named **Chandler L. Burns Hall** in memory of Billy and Ann's grandson, Chandler, who died from an unexpected illness in 2016. A proud 2015 Clemson graduate, Chandler received his bachelor's degree from the Nieri Family Department of Construction Science and Management. He will forever be remembered for his heartwarming smile, strong work ethic, and his love and devotion for all things Clemson. I cannot imagine a more meaningful and appropriate way to honor Chandler's legacy of boundless commitment and enormous Clemson pride than to name an educational space in the new **Wilbur O. and Ann Powers College of Business** in honor of him. 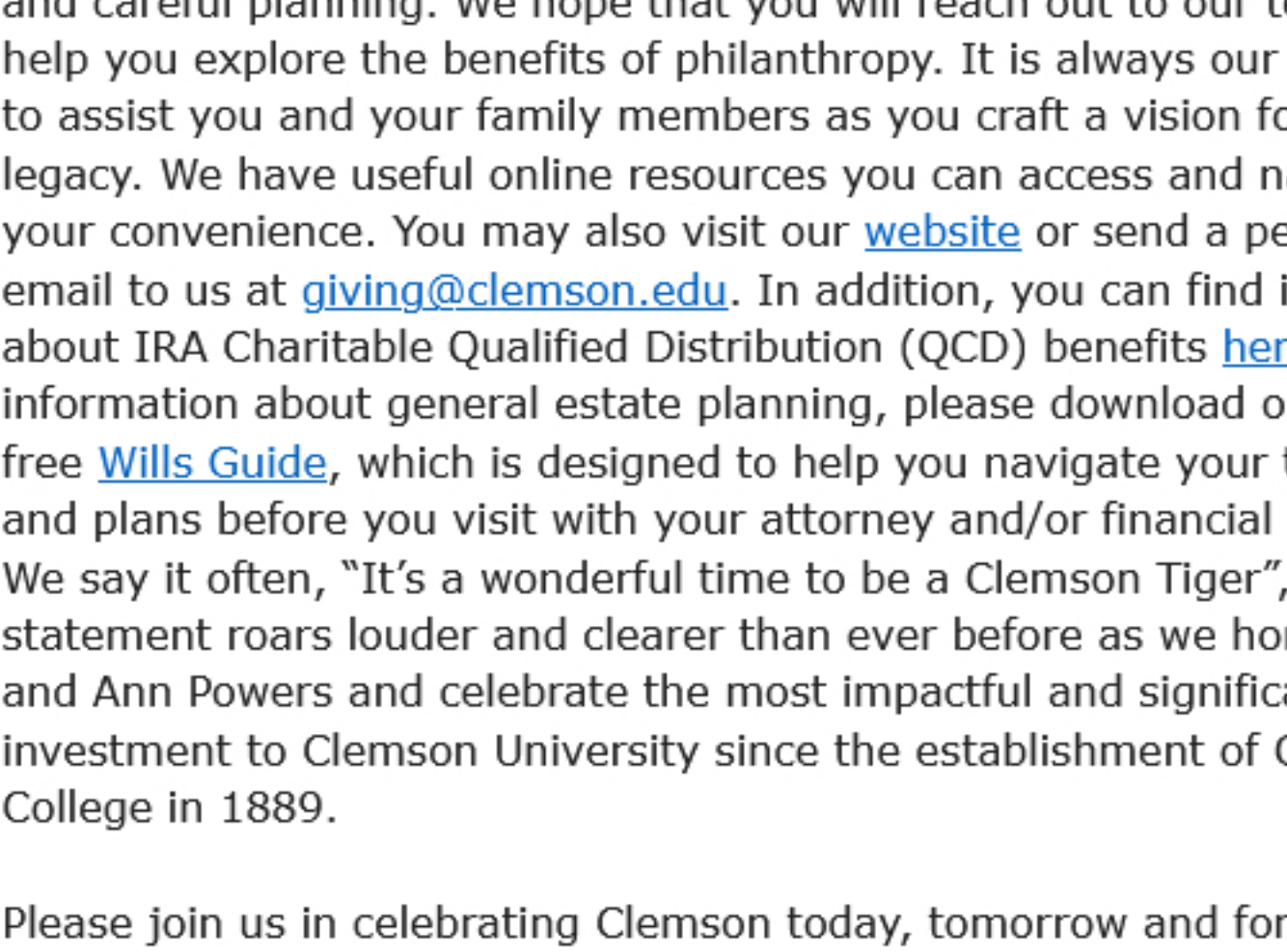

Billy, with his wife, Ann, went on to build a prosperous career and become one of Clemson's most successful alumni and a top entrepreneur in our state. Billy and Ann have been partners in life and business for more than 38 years. In 1965, Billy launched his own business, Powers Construction, which has grown into a large-scale construction firm – building schools, churches, condominiums and government buildings across the Carolinas. Billy and Ann then worked to establish 50 other businesses stretching from Mexico to Canada. Ann and Billy are renowned for their quiet philanthropy to those in need, and they live each day in service to others.
