


Greetings, Clemson Family!


Each year during the month of April we honor Clemson University's founder, Thomas Green Clemson, who died on April 6, 1888. To commemorate his and Anna Calhoun Clemson's transformational philanthropy in establishing this great University, we celebrate Founder's Day. On May 22, 1888, the seven original successor trustees met under an oak tree on the lawn of Fort Hill where their task was to shepherd the acceptance of Thomas Clemson's will by the state legislator. On December 24, 1888, Clemson's will passed in the statehouse to make Clemson University (then Clemson Agricultural College of SC) a reality. We honor their legacy that instituted this "high seminary of learning" which has spanned across 130 years of excellence in education for the people of South Carolina, our region and nation.



It is also fitting that during this month we hold our annual Give Day in which we come together as the Clemson Family to celebrate the power of your generosity, honoring our University's history of philanthropy. 
More than 80 years after Thomas and Anna Clemson's dream became a reality, their generosity changed the life of a young man from the small town of Mullins, SC as he arrived on campus in 1972. When you speak with Jack McKenzie '76 of Clemson, SC, it is hard to imagine that upon arriving to campus, he knew almost no one. The day he arrived, his older brother, Dupree, said goodbye to him in front of the iconic clock tower at Tillman Hall. Jack then found his way to the assigned sixth floor room of the Johnstone dormitory - right behind the tower. The Clemson campus, compelling and beautiful, was a vast change from Mullins where Jack spent his youth. As he explored campus for the first time, the clock tower readily became the landmark he would immediately trust. "That clock tower has always been a special symbol to me. That day, it told me where my home was. And since then, I've known that as long as I can see the clock tower, I'm where I'm supposed to be. Clemson is my home."



Attending Clemson gave Jack the opportunity to grow in independence as an individual and emerge as a thoughtful leader. He found many of his closest friends and deepest connection to the Clemson Family as a member of the Alpha Phi Omega Gamma Lambda Chapter (APO). A service fraternity, APO helped to nurture and develop service and leadership qualities Jack intrinsically possessed. After graduation, Jack spent most of the next four decades faithfully serving and leading in numerous roles for the University. Throughout those years, Jack played an integral part to empower and significantly increase the capacity for Clemson to transform the lives of students, faculty and staff. Jack's own generosity stems from his personal experiences while serving in APO as a student and time spent dedicated to his career at Clemson. For that reason, Jack followed in the hallowed footsteps of Thomas Green and Anna Calhoun Clemson and made his lasting mark by directing support from his estate to the **Alpha Phi Omega Gamma Lambda (APO) Chapter Endowment for Service Excellence**, which provides service and leadership opportunities to Clemson students.
